As you experienced with your 2019 tax return, Kirsch CPA Group will continue to use SafeSend Returns to deliver your tax return right to your inbox, allowing you to e-sign your tax return, make payments to the IRS and download a copy to your computer – all while remaining safely at home.

To allow you to safely and securely upload your 2020 tax information to us, we are adding SafeSend Exchange to the Kirsch website. With no passwords to remember, SafeSend Exchange allows you to easily upload your digital tax documents directly to us without first logging into an account. Don't have a digital copy? Use one of the many scanner apps such as TurboScan to scan a copy to your phone and upload it to us via the Kirsch website. Safe Send Exchange will replace exchanging files with us using the Kirsch portal and provide a user-friendly interface for sending your tax documents to us.

Here's the process -

- 1. Visit the Client Center at www.kirschcpa.com for a 2020 tax checklist and engagement agreement.
- 2. Complete your 2020 tax checklist and gather all of your tax documents.
- 3. Go to www.kirschcpa.com click the Secure File Upload at the top of the page and upload your 2020 tax checklist and tax documents no later than March 22, 2021.
- 4. Our team will prepare your tax return and contact you with any questions.
- 5. Your completed tax return, payment vouchers and an invoice from Kirsch will be delivered to you via SafeSend Returns.
- 6. Review your tax return and sign the e-file authorization form (Form 8879).
- 7. Review and pay your Kirsch invoice for professional services.
- 8. If applicable, pay all tax due to Federal and State.
- 9. If applicable, print city/local tax returns, sign and mail (with payment due if required).

DEADLINE - Submit your tax information to us no later than March 22, 2021

The tax filing deadline this year, without extension, is April 15, 2021. We recommend that you compile your information and upload all your documents to us as soon as possible. Tax returns are prepared on a "first-come, first-served" basis. After March 22nd, your return may be extended.
